Meeting Synopsis

The meeting started at 1:04 p.m. on Tuesday, July 23, 2024, but was not officially called to order by Adam Lougee, the Chair of the Policy Committee at 1:06 p.m. when quorum was met.

Following the acceptance of the agenda and the roll call, Adam Lougee, the Chair of the Policy Committee opened the meeting to public comments for up to ten minutes. Eleven public participants were present. One member of the public, Tim Cowan (Vergennes), shared his opinions on the proposed route alternatives.

The meeting included a presentation from members of the study team who provided a brief study overview, study timeline and the role of the Policy Committee. The team then reviewed land use visioning including land use scenarios that are outlined in the Land Use Visioning Technical Memorandum. The purpose of the meeting was for the Policy Committee to reach consensus on approving the land use visioning scenarios and technical memorandum. Members of the Policy Committee were encouraged to ask questions and provide additional feedback on the Land Use Visioning Technical Memorandum.

The Policy Committee was asked, "Based on your review of the Land Use Visioning Technical Memorandum, do you recommend the land use visioning scenarios for approval?" Chair, Adam Lougee asked for consensus from all the voting members. Of the eighteen voting Policy Committee members, ten were present to vote. Ten responded "yes," none responded "no." A consensus was reached. The Policy Committee recommends that the land use visioning scenarios in the Land Use Visioning Technical Memorandum be approved, including the recommendations made by Representative Lanpher and Rhonda Williams. The motion passed at 1:36 pm.
